## OSCEOLA WATER BOARD October 6, 2016

The Osceola Water Board met for the regularly scheduled meeting on Thursday, October 6, 2016 at 5:30 P.M. This being the time and place as legally posted, the meeting was called to order by Chairman Alisha Kale with the following Board Members present: Larry Bishop, MacKenzie O'Hair, Laura Castro and Mark Binning. Also present were Superintendent Brandon Patterson, Utility Office Manager Carrie Benda and others not signed in.

Board member O'Hair motioned to approve the agenda as presented and Bishop seconded the motion.

Utility Office Manager Carrie Benda opened the discussion regarding the waiver of penalty for Osceola Foods by presenting the request received from Osceola Foods. Mrs. Benda stated that the rule the board put in place August 11, 2015 allows for an account holder to request a one-time penalty waiver of the 10% penalty if the account has been paid in full by the due date (15<sup>th</sup>) for a period of twelve months (one year) prior. Mrs. Benda stated that Osceola Foods would qualify for this waiver per policy and if approved, a credit would be placed on the account for the next available billing. After discussion, board member Castro motioned to approve the penalty reversal per policy and Binning seconded the motion.
