OSCEOLA WATER BOARD July 7, 2022

The Osceola Water Board met for the regularly scheduled meeting on Thursday, July 7, 2022 at 5:30 P.M. This being the time and place as legally posted, the meeting was called to order by Chairman Alisha Kale with the following Board Members present: Larry Bishop, James Kimball, Sara O'Hair and Kevin Rivera. Also present were Superintendent Brandon Patterson, Utility Billing Director Carrie Benda Water Distribution Foreman Cory Gallup, Helen Saylor Kimes and others not signed in.

Board member Bishop motioned to approve the agenda as presented and board member Kimball seconded the motion.

No one was present to address the board about items not on the agenda.

Water Superintendent Brandon Patterson opened the discussion regarding meter pit installation requirement for Community Builders by providing information in the Water Works Rules and Regulations and history information behind meter pits. Mrs. Saylor Kimes spoke to the board about the lot requirements and requested the twelve lots already platted to be grandfathered in to use only curb stop and the remaining additional eighteen lots would be required for the meter pits as per rules and regulations. Board member Bishop motioned to grandfather the twelve lots already platted be allowed to use curb stops and if any curb stops are unfunctional, the property owner would be responsible for repairs. The motion failed as there was no second. After further discussion, the board took no action of waiver of the meter pit requirement.

Water Superintendent Brandon Patterson opened the discussion regarding the purchase of a hydrovac by stating this has been an item that has been budgeted for an extended period of time. Water Distribution Foreman Cory Gallup spoke of the purpose of the hydrovac and how they would use it at the Water Works facility. Mr. Gallup went over the options of quotes received from Vermeer and Ditch Witch. After discussion, board member Kimball motioned to purchase the Vermeer machine using capital funds in the amount of \$55,200.00 and Bishop seconded the motion.

Water Superintendent Report: Brandon Patterson shared with the board information regarding the center water tower updates and items of concern as well as possible upcoming website updates.
