The Osceola Water Board met for a Special Board meeting on Wednesday, September 27, 2023. This being the time and place as legally posted, the meeting was called to order at 1:01 P.M. by Chairperson Alisha Kale, with the following Board Members present: Sara O'Hair, Larry Bishop, Jim Kimball and Sandra Ramos. Water Superintendent Brandon Patterson opened the discussion regarding Modifications to The Water Conservation Ordinance Sections 3—5 and reported on West Lake levels. Currently we are in Section 2: Water Warning of the Water Conservation Ordinance.

Mr. Patterson reported divers are returning to West Lake on Saturday, September 30, 2023 to gather additional data and to prepare the lower intake pipe for modification. Divers are scheduled to return November 4th to install intake modifications on the lower intake.

Water Conservation Ordinance Section 3: Water Emergency – Restrictions, Section 4: Water Crisis – Restrictions, and Section 5: Penalties, were discussed for Residential, Commercial, Institutional, and Industrial water use. Each Section' Penalties, Violations, Base Allocation, Premium Rate for Imprudent Usage and Adjustment of Premium Charges were also discussed. Board member Kimball motioned to approve all changes as discussed, Bishop seconded the motion. Roll Call of the Vote was:
